Buy any Michelin New 22.5" product and receive £22.50 cashback.

1. This Promotion applies to purchases made between [1<sup>st</sup> September 2021 and 31<sup>st</sup> October 2021](#).
2. This Promotion is a cashback offer where an amount (plus VAT) will be refunded by bank account transfer (**Cashback**). Further details are set out in these terms and conditions.
3. By participating in this Promotion, customers agree to be bound by these terms and conditions and by any other requirements set out in the promotional material. The Promoter reserves the right to refuse entry or refuse to award the Cashback to any customer in breach of these terms.
4. MyPortal registration necessary - customers must register on the Promoter's MyPortal website (<https://myportal.michelingroup.com>) (**MyPortal**) to benefit from this Promotion. The Promoter reserves the right to refuse the Cashback if customers fail to register on MyPortal in accordance with the details set out in clause 6.

  - 6.2 ensure you are registered on the Promoter's MyPortal;
  - 6.3 upload your purchase invoice to MyPortal between 1st September 2021 and 30<sup>th</sup> November 2021; and
  - 6.4 receive a Cashback amount of £22.50 (plus VAT) per qualifying tyre.
7. Cashback payment will be made via bank transfer to the customer's nominated bank account within 28 days from receipt of the uploaded purchase invoice.
8. Customers can claim the Cashback on a maximum of 100 tyres during the Promotion. Each claim must have a separate and identifiable tyre purchase transaction.
